Welcome to CHERRIES | Responsible Healthcare Ecosystems

Dear reader,

welcome to the first issue of our newsletter, a *virtual window* on CHERRIES Responsible Healthcare Ecosystems.

Over the next two years and a half we will tell you about the Responsible Research and Innovation (RRI) policy experiments in the healthcare sector our consortium will first run in three European territories — in **Murcia** (ES), **Örebro** (SE) and the **Republic of Cyprus** (CY) - and will then extend to other regions.

As you might imagine, the COVID-19 pandemic impacted our activities, as the European healthcare sector has been -and still is- on the front of this emergency. Still, we took this time to observe regional healthcare ecosystems and better prepare ourselves to support territories improving their innovation policies through RRI and demand driven approaches to the definition and co-creation of innovative solutions to the challenges identified in the healthcare sector.

Our team applies the RRI framework to mobilise territorial stakeholder ecosystems and engage them into regional pilot actions aimed at:

- 1. identifying needs in the healthcare sector at territorial level
- 2. encourage the proposition and co-creation of innovative solutions to the identified needs
- 3. stimulate institutional reflection processes on how to innovate products and services in the healthcare sector through participatory approaches
- 4. present evidence-based recommendations for revision of sectoral policies, strategies and innovation support instruments.
