CHERRIES Territorial Training Workshops | what's happening in the CHERRIES regions?

During October and November CHERRIES territorial partners arranged regional "Training workshops" aimed at engaging and preparing the local system of stakeholders for the experimental phase of the project. These events were designed in collaboration with Knowledge & Innovation as an itinerary of reflection and capacity building on RRI-based demand articulation, experimentation, and co-creation processes in health by involving key territorial multipliers and stakeholders of the Healthcare R&I ecosystem (providers, policymakers, payors, patients).
